Levels of Membership as per the by laws:

Professional Active will be an individual which meets existing requirements for membership but also holds a PPA National ID number. These photographers will have a voting membership as long as their membership remains in good standing. They will have annual dues of \$25.

Association Membership will be an individual that meets existing requirements as well as holds a State Sales Tax ID number. These photographers will have identical benefits with the exception of voting. They will have annual dues of \$25.

Friends of GSL will be an individual who may not meet the existing criteria for membership regarding income from photography but may be a student academically pursuing photography, a spouse of a member, an employee of a member, a retiree, or a representative of a business association. These members will not have a vote. They will have annual dues of \$15.
