

8x10 Print Competition-2010

Official Rules: 6 entries allowed per print case. 1 print case per photographer.

To Qualify for competition in the Greater St. Louis Professional Photographers Awards (PPAGSL), each entry must:

Be taken by the person entering the image into competition.

Be an unframed 8x10 inch print mounted on a board 1/8 in thick or less.

Be recent: Not more than 2 years old.

Be accompanied by a completed official entry form attached to the back of the print, and a summary form. Photocopies of the entry forms are acceptable.

Be accompanied by an **entry fee of \$25 for members and \$35 for non-members**. Checks made payable to PPAGSL.

Applicants agree that any entered photograph may be used by PPAGSL in any publications or on the website. Model releases must be available for all recognizable individuals in submitted photos. Do not submit these releases unless requested.

All photographs must be hand carried to the competition site; the entries must arrive by 12:30 pm the day of the competition. No shipping is available. Winning and non-winning photographs must be picked up following the awards presentation. PPAGSL cannot be liable for any photograph(s) submitted.

All Photographs must have name and address on the back. The photographers name must not appear on the front of the image. Entries will be disqualified if the photographers name appears on the front of the image.

Albums may be entered as 1 or more of your image entries with no more than 6 entered in a case. Remember the makers name must not be visible to the judges.

Photographs entered into the PPAGSL competition will be judged for the photographic artistry and craftsmanship. The decision of the judges is final.
